Memorandum of Understanding for Earned -Relief Volunteer Services

This Agreement is made on _____, 2022, by and between _____, and SISU DARKHORSE (hereinafter "SDH") and the ATHLETE or Parent/Guardian of _____. (Hereinafter "Ath/Prnt ")

Volunteers of SDH intend to donate their time or services to SDH through the below named activities, and SDH intends to accept donation of Volunteer services in lieu of membership dues. Both parties agree as follows:

The Ath/Prnt may donate and provide volunteer services to SDH in the capacity of FUNDRAISING activities that shall include, but may not be limited to, the following:

Activities : Managing/ Volunteering at

SDH hosted a Bingo Game.

SDH hosted auctions.

SDH hosted casino night.

SDH hosted Car Wash.

SDH Concessions.

SDH Raffles.

SDH Holiday Special events (ex Consider Santa Photographs, gift-wrapping, haunted houses, easter hunt)

Advertising Sales. Prepare programs with advertising for home events and tournaments. Sell advertising space and distribute or sell programs to the spectators.

Transporting other SDH athletes to practice.

Selling. SDH Wrestling merchandise.

Acting as Volunteer through SDH does not qualify an individual for workers' compensation benefits, and Volunteers are responsible for their own personal medical expenses for any injuries incurred while performing volunteer services.

Volunteers shall follow the supervision and direction of any personnel, employee or Volunteer Leader to whom the Volunteer has been assigned to perform services, and shall participate in any training required by SDH in order to perform the voluntary services.

Notwithstanding anything to the contrary in this Agreement, SDH shall have the absolute discretion to refuse to accept any volunteer for participation, and the sole right to terminate unilaterally at any time, any volunteer who does not meet the performance requirements of this Agreement thus making the ATH/PRNT responsible for the remaining balance of Due payment.

Volunteer hours are carried over month to month.

Term: The term of this Agreement shall be from JANUARY 1ST 2022 through Dec 31 2022. Unused volunteer services will carry over to the next year of participation. If a call to volunteer is denied 3 consecutive times then Athletes will be allowed to watch but not participate in SDH practice until an Earned relief opportunity is served or dues paid.

EARNED RELIEF EXAMPLE: If Athlete "Jimmy" attends a full month of SDH Practice and can afford \$20 then the remainder balance of 40\$ will be noted. Owed volunteer time is calculated using the following formula.

Amount owed / 9.87 = OWED VOLUNTEER TIME IN HOURS

EX: JIMMY OWES \$40 / 9.87 = 4.05 owed volunteer time in hours.
